Introduction


Carbon Reduction Projects

The schemes below have contributed to a reduction in greenhouse gas emissions and the measures will be in effect when performing the contract. We are not currently able to calculate the tCO2e reduction achieved by these schemes or the corresponding percentage reduction achieved against the 2022 baseline. To continue to progress towards achieving Net Zero, we are currently looking at running a number of Carbon Reduction projects.

Completed Carbon Reduction Initiatives

- We have procured certified 100% renewable electricity contracts for all our owned supplies.
- Closely working with suppliers to influence their commitments to reducing Carbon emissions.
- Continue to encourage a hybrid-working environment, reducing travel for staff and creating an environment that's more sustainable and more inclusive for all.
- Ensuring travel is kept to a minimum, with virtual meetings used where appropriate, further reducing our travel footprint.
- From September 2022 we began using only 100% recyclable packaging for order processing.
- Installation of a new thermostatic, energy efficient heating system. This system was installed in July 2023.

Future Carbon Reduction Initiatives

Over the next few years, we plan to implement further measures which will continue to drive down our emissions. These include the following initiatives:

- We will build awareness amongst our workforce of the impact of their decisions on our journey to net zero by holding company wide engagement sessions.
- We have shared an Environmental Management Awareness e-learning course with all of our employees.
- Work with key individuals on carbon reduction plans, such as assessing our stock
 holding and reducing the frequency of repeat orders. Working with suppliers to reduce
 emissions in the wider supply chain.

- Continue to procure 100% renewable electricity for owned sites.
- Encouraging greener transport options for employee commuting, including carpool initiatives.
- Conduct a full review of waste/water/material usage to identify initiatives to reduce carbon emissions.
- Work with delivery partners to achieve carbon neutral delivery for all ecommerce purchases by 2030.
- By 2035, fully electrify our staff fleet.
- Move website hosting to Green Hosting Services by 2026
- Unavoidable emissions will be balanced with actions that remove an equal amount of carbon dioxide (CO2) or its equivalent in other greenhouse gasses (GHGs) from the atmosphere, effectively achieving a 'net zero' impact on the environment by 2045.

Each initiative will be tracked and measured in terms of reduction in energy saving and C02 saving.
